(CRRR) nor Portland Riverside Marina have any duty to nor have any control over the actions of the undersigned, either on the water or on land. **Each signer**, hereby agrees that they have no rights or claims against CRRR, it's officers and directors, as well as Portland Marina and that each of the undersigned, agree to take responsibility and control of themselves and any person invited by the signer to this event and hold CRRR and Portland Marina harmless for any injuries to such persons or caused by such persons.
